The HR Sub-Section had "been active for more than two years". Tina Giallonardo was its leader. They were busy defining and redefining job descriptions for the VALA Salary Survey.

Peter Asselstine was the President that year.

I remember the newsletter by colors. We started with white photocopy paper, then we went to gray (we must have thought it was elegant!). When pitching story ideas and articles to the local press it is vital to talk and write in plain language. Reporters and editors don't have a deep grasp of the law. Boil down the important points for them into easy-to-understand language.

In order to build a rapport with a journalist consider giving the journalists story ideas, even when the stories have nothing to do with your firm. If you are able to supply them with interesting ideas then they will be more receptive to your stories in the future.

And beware. Don't use advertising dollars to try and buy editorial copy. Journalists are insulted by the notion and will be sure to avoid your contributions in the future.


